Decision number 1029.1 – 02-02-2021

Having heard the:

- Board;
- Stichting Asterion.

and considering that:

- Stichting Asterion has requested a recognition as Foundation in the sector Other;
- Stichting Asterion is considered to comply with the recognition regulations;
- Stichting Asterion does not use facilities that require a facility card.

the Student Union board decides to:

Temporarily recognize Stichting Asterion as Foundation without facility card obligation in the sector other.

- The umbrellas are a great advice council for us, since they know what happens within the sectors and use that to advise us on different matters.

the Student Union board decides to:

Grant the following rights to the umbrellas until 31-12-2021:

the right to be involved in:

- the making of the strategic and annual plans including the finances;
- the making of policies specific for the sector of the umbrella organisation;
- the making of advices towards the UT regarding the profiling fund (FOBOS) policy;
- the making of changes of the recognition regulations.
- setting up initiatives for the student organizations
- right to be involved in initiatives being set up for the student associations or their sector
- the right to advise the supervisory board for decisions of the supervisory board regarding:
- the strategic and annual plans including the finances, and the corresponding reports;
- policies specific for the sector of the umbrella organisation;
- non-confidential decisions directly related to (organizations in) the sector of the umbrella organisation;
- changes of the statutes and forthcoming documents (incl. recognition regulations).

Decision 1031.1 – 16-02-2021

and considering that:

- The pilot procedure will continue as the new permanent procedure for fulltime activism recognition (FT AR) because:
 - It is less time consuming for both students as the AR committee
 - It is better for the personal development of students than the previous FT AR procedure (see BF decision 999.01)
- The pilot procedure will continue as the new permanent procedure new procedure for parttime activism recognition because:
 - It helps parttimers in personally developing as well as getting appreciation of the UT/SU.
 - It is not too time consuming for the AR committee.

Decision number 1032.2 – 23-02-2021

Having heard the:

- Board;
- WAR

and considering that:

- All decisions written below are deliberately discussed with the Werkgroep Afstudeer Regelingen (WAR)

the Student Union board decides to:

support the following decision of the WAR:

- The C+1 regulations will start from the moment a student is enrolled in higher education
- The extend of FOBOS support will not have a maximum amount, and a maximum of 18 grants in total
- First-year Bachelor's students can only apply for a maximum of 3 part-time grants before their first year is successfully completed
- For full-timers for every 5 EC obtained during their active period, 1 grant will be deducted from the total. For more than 15EC, the full-time grants will be converted into part-time grants.
- The financial support per grant for full-time activities is equal to the average tuition fees paid in the recognized period.
- The part time grant of 170 euro will stay the same amount with the new regulation for tuition fee. One full time grant is determined of 1/12 of the paid tuition fee but will not be less than a part-time grant.
