

Subsidies from the Stimulation Fund

The number of years an association can make use of subsidies from the Stimulation Fund depends on how many years the current FAM is still active. A FAM cycle is 4 years long. A new association can enter the FAM in the next FAM cycle after which no more Stimulation Fund subsidies can be requested. Therefore:

- If an association is established and requests Stimulation Fund subsidies in the first year of the FAM, it can get subsidies for 4 years, namely until a new FAM cycle is entered. So the 1st year until the 4th year columns of the table below are applicable.*
- If an association is established and requests Stimulation Fund subsidies in the second year of the FAM, it can get subsidies for 3 years, namely until a new FAM cycle is entered. So only the 1st year, 2nd year and 3rd year columns of the table below are applicable.*
- If an association is established and requests Stimulation Fund subsidies in the third year of the FAM, it can get subsidies for 2 years, namely until a new FAM cycle is entered. So only the 1st year and 2nd year columns of the table below are applicable.*
- If an association is established and requests Stimulation Fund subsidies in the fourth year of the FAM, it can get subsidies for 1 year, namely until a new FAM cycle is entered. So only the 1st year column of the table below is applicable.*
